0 E	EC informed of SRReq Work Item	The European Commission is informed that a Work Item under Standardisation Request is created in the ETSI Work Programme.
0 Er	EC SRReq confirmed	The European Commission has officially approved and confirmed the Standardisation Request (SRReq).
0 CA	Work item change initiated	Changes to the Work Item under the Standardisation Request were required. The Work Item is re-submitted to the National Standardization Bodies (NSBs) for adoption over a 28 calendar-day period. This period may be shortened to 14 calendar-day period only in exceptional cases, provided there is a valid justification, in accordance with the ETSI Directives. The National Standards Organisations (NSOs) and Annex III organisations are also consulted during this process; however, they do not have voting rights.
0 CB	Work item change closed	The vote to accept changes to the Work Item under a Standardisation Request has been closed. The results and any accompanying comments can be accessed through the e-Approval application (access is restricted to authorised users).
0 CR	Work item change failed	The vote to change the Work Item under a Standardisation Request has been unsuccessful.
0 SA	Work item stopping initiated	The Work Item under a Standardisation Request is submitted to the National Standardization Bodies (NSBs) for a vote to stop it, conducted over a 28 calendar-day period. This voting may be shortened to 14 calendar-day period only in exceptional cases, provided there is a valid justification, in accordance with the ETSI Directives. The National Standards Organisations (NSOs) and Annex III organisations are also consulted during this process; however, they do not have voting rights.
0 SB	Work item stopping closed	The vote to stop the Work Item under the Standardisation Request has been closed. The results and any accompanying comments can be accessed through the e-Approval application (access is restricted to authorised users).
0 R	Work item Adoption failed	The vote to adopt the Work Item under a Standardisation Request has been unsuccessful.
0 SR	Work item stopping failed	The vote to stop the Work Item under a Standardisation Request has been unsuccessful.
7 S	SRDoc enquiry	Formal consultation or public review period during which the draft Standardisation Request Document is circulated to stakeholders—such as National Standards Organisations (NSOs), National Standardisation Bodies (NSBs), industry experts, and interested parties—for comments and feedback.
7 V	EC assessment before EV requested	The European Commission is asked to review and evaluate the submitted draft before the approval procedure is launched.
7 Vr	EC assessment before EV received	The European Commission has completed its review or evaluation of the submitted draft before the approval procedure is launched. And has officially communicated its comments, requests for changes, etc.
7 W	Draft after EC comments	The draft is updated considering the comments and requests for changes received from the European Commission.
7 X	Resolution of EC comments	The European Commission's feedback is considered and acted upon to improve or finalize the document.
9 Cv	EC assessment before WNV requested	The European Commission is asked to review and evaluate the submitted draft before the Weighted National Vote is launched..
9 Cvr	EC assessment before WNV received	The European Commission has completed its review or evaluation of the submitted draft before the Weighted National Vote (V) is launched and has officially communicated its comments, requests for changes, etc.
9 Cw	Draft after EC comments	The draft is updated considering the comments and requests for changes received from the European Commission.
9 Cx	Resolution of EC comments	The European Commission's feedback is taken into account and acted upon to improve or finalize the document.
12 VA	Clarification requested by the EC	A report from the European Commission was received, prompting a request for clarification.
12 VB	Clarification sent to the EC	The ETSI Secretariat has formally communicated its clarification to the European Commission.
12 WA	Start of Withdrawal Vote	A published European Harmonised Standard (hEN) or European Standardisation deliverable is submitted to the 'Vote Withdrawal' (VW) phase of the Standardisation Request deliverable Approval Process (SRdAP), which lasts 60 calendar-day period. <b>National Standardisation Organisations (NSOs)</b> are responsible for <b>collecting comments</b> from stakeholders and submitting them electronically to the ETSI Secretariat. <b>National Standardisation Bodies (NSBs)</b> are the <b>only entities authorised to cast votes</b> during the procedure. <b>Annex III organisations</b> are also consulted and may provide comments, but <b>do not have voting rights</b> , unlike the NSBs. 12 WB	End of Withdrawal Vote	See clauses 21.2 and 21.5 of the ETSI Rules of Procedure (V51) for further details.
12WW	No more cited in the OJ	The Deliverable (EN) is no more cited in the Official Journal of the European Union (OJEU).
